In accordance with Section 505 of the Trust Agreement on the Oklahoma Turnpike System, the Authority must prepare a budget for the ensuing Calendar Year and file copies of same with the Trustee, Depository, Consulting Engineers, Traffic Engineers and all Bondholders who have filed their names for such purpose. Therefore, the Proposed Annual Budget for the Oklahoma Turnpike System for the Calendar Year 2025 is submitted for the consideration of the Authority. This detailed budget document as attached, is in the amount of \$156,267,926 for operations and maintenance of the turnpike system. Additionally, a \$165,495,322 Capital Budget for 2025 is incorporated.

This budget document as attached, is in the amount of \$1,331,006 for operations and maintenance of the Gilcrease Turnpike.

It is recommended that the Authority adopt the 2025 Operating and Maintenance Budget in the amount of \$1,331,006.

Annual Budget Non-System O&M Account and Major Maintenance Reserve Account

The following summarizes certain key requirements under the Non-System General Trust Agreement between the Oklahoma Turnpike Authority (the "Authority") and BOKF, NA (the "Trustee") dated as of May 8, 2020 (the "Non-System Trust Agreement"). Capitalized terms used herein have the meanings provided in the Non-System Trust Agreement.

ANNUAL BUDGET PROCESS

Section 504 of the Non-System Trust Agreement requires that on or before the tenth (10th) day of October of each Fiscal Year, commencing with the October 10 immediately preceding the Fiscal Year in which Substantial Completion of the Initial Project (i.e., the Gilcrease Expressway West Project) is projected to occur, it will prepare a preliminary budget of:

(a) monthly deposits to the credit of the O&M Account such that as of each applicable Semi-Annual Payment Date the O&M Account is funded with an amount equal to the aggregate amount of Operations and Maintenance Expenses expected to be paid or incurred by the Authority in the six (6) month period ending on the date immediately prior to such Semi-Annual Payment Date;

(b) monthly deposits to the credit of the Major Maintenance Reserve Account for the ensuing Fiscal Year;

(c) the amounts and purposes of any Operations and Maintenance Expenses for the reimbursement of which moneys held for the credit of the O&M Account will be transferred to the Authority semiannually in accordance with Section 512(c); and

(d) the amounts and purposes of any Major Maintenance Cost for which moneys held for the credit of the Major Maintenance Reserve Account will be disbursed from time to time in accordance with Section 511(a) (herein referred to as the "**Preliminary Budget**").

Each Preliminary Budget is required to reflect the scope of work and services recommended by the Consulting Engineers for the proper maintenance, repair and operation of the Financed Projects during the ensuing Fiscal Year pursuant to Section 503 (summarized below) and in no event shall any Preliminary Budget provide for (x) a greater aggregate amount for monthly deposits to the credit of the O&M Account during the ensuing Fiscal Year than recommended by the Consulting Engineers pursuant to Section 503 or (y) any change to the amount for monthly deposits to the credit of the Major Maintenance Reserve Account during the ensuing Fiscal Year from the amount recommended by the Consulting Engineers pursuant to Section 503. On or before the twentieth (20th) day of each such October, copies of each such Preliminary Budget shall be filed with the Trustee and mailed by the Authority to the Consulting Engineers.

The Authority further covenants that on or before the first (1st) day of December in each such Fiscal Year it will finally adopt the budget of monthly deposits to the credit of the O&M Account for Operations and Maintenance Expenses and of monthly deposits to the credit of the Major Maintenance Reserve Account for Major Maintenance Costs, in each case, for the ensuing Fiscal Year and the amounts and purposes for which moneys held for the credit of the O&M Account and the Major Maintenance Reserve Account, respectively, will be disbursed (herein referred to as the "**Annual Budget**"). Each Annual Budget shall reflect the scope of work and services recommended by the Consulting Engineers for the proper maintenance, repair and operation of the Financed Projects during the ensuing Fiscal Year pursuant to Section 503, and in no event shall any Annual Budget provide for (x) a greater aggregate amount for monthly

deposits to the credit of the O&M Account during the ensuing Fiscal Year than recommended by the Consulting Engineers pursuant to Section 503, (y) any change to the amount for monthly deposits to the credit of the Major Maintenance Reserve Account during the ensuing Fiscal Year from the amount recommended by the Consulting Engineers pursuant to Section 503 or (z) total appropriations in any portion thereof that exceed the total appropriations in the corresponding portion in the Preliminary Budget. On or before the tenth (10th) day of December in such Fiscal Year, copies of the Annual Budget shall be filed with the Trustee and mailed by the Authority to the Consulting Engineers, the Traffic Engineers and all Bondholders who shall have filed their names and addresses with the Secretary and Treasurer of the Authority for such purpose.

ANNUAL INSPECTION AND REPORT BY CONSULTING ENGINEERS

Annual Inspection of Financed Projects Section 503 of the Non System Trust Agreement requires that that the Authority cause the Consulting Engineers employed by it under the provisions of Section 706 of the Non-System Trust Agreement, among such other duties as may be imposed upon them by the Authority or by the Non-System Trust Agreement, to (a) make an inspection of each Financed Project at least once in each year, commencing with the year in which Substantial Completion of the Initial Project occurs, and (b) by the 1st day of October in the Fiscal Year prior to the Fiscal Year in which Substantial Completion of the Initial Project is projected to occur and by the 1st day of October in each Fiscal Year thereafter, to submit to the Authority and the Trustee a report setting forth (x) its findings as to whether the Financed Projects have been maintained in good repair, working order and condition, and (y) its recommendations as to:

(i) the proper maintenance, repair and operation of the Financed Projects during the ensuing Fiscal Year (including any Financed Project the Completion Date of which is projected to occur in such ensuing Fiscal Year) and an estimate of the amount of money necessary in each month of the ensuing Fiscal Year for such purposes, provided that, for any period prior to the TIFIA Security Discharge Date, such estimate shall be prepared in accordance with the protocol set forth as Schedule 503 to the Non-System Trust Agreement;

(ii) the insurance to be carried under the provisions of Sections 707 and 708 of the Non-System Trust Agreement;

(iii) assuming that Operations and Maintenance Expenses are paid or incurred by the Authority in the amounts and at the times recommended by the Consulting Engineer pursuant to clause (i), the amount that should be deposited monthly during the ensuing Fiscal Year to the credit of the O&M Account such that as of each applicable Semi-Annual Payment Date the O&M Account is funded with an amount equal to the aggregate amount of Operations and Maintenance Expenses paid or incurred by the Authority in the six (6) month period ending on the date immediately prior to such Semi-Annual Payment Date; and

(iv)(A) the Major Maintenance Costs projected to be incurred by the Authority in each Major Maintenance Year and (B) the amount that should be deposited monthly during the ensuing Fiscal Year to the credit of the Major Maintenance Reserve Account to be applied or held in reserve for the purposes set forth in Section 511 of the Non-System Trust Agreement, such that by the end of such ensuing Fiscal Year the Major Maintenance Reserve Account is funded with an amount equal to the sum of (1) 100% of the Major Maintenance Costs projected to be incurred by the Authority in the first Major Maintenance Year, plus (2) 80% of the Major Maintenance Costs projected to be incurred by the Authority in the second Major Maintenance Year, plus (3) 60% of the Major Maintenance Costs projected to be incurred by the Authority in the third Major Maintenance Year, plus (4) 40% of the Major Maintenance Costs projected to be incurred by the Authority in the fourth Major Maintenance Year, plus (5) 20% of the Major Maintenance Costs projected to be incurred by the Authority in the last Major Maintenance Year.

Fiscal Year 2025

The amounts to be expended in respect of Operations and Maintenance Expenses for Fiscal Year 2025 were prepared in accordance with the requirements described on the previous pages. The planned Operations and Maintenance Expenses to be expended in this budget are to be funded from deposits to the O&M Account during Fiscal Year 2025 and paid strictly in accordance with the requirements of the Non-System Trust Agreement. The total amount of budgeted Operations and Maintenance Expenses for Fiscal Year 2025 is \$1,331,006, and the monthly deposits to the C&M Account are as follows:

Submitted for consideration and approval of the Authority is a request to authorize the Director to negotiate and execute an extension to the existing tag fulfillment contract with Oklahoman Direct for an extended term of up to 12 months, ending December 31, 2025. The amount due during the extension shall not exceed \$240,100, revising the not to exceed contract amount previously approved from \$1,115,000 to \$1,355,100.

This contract was authorized pursuant to Board approval of Agenda item 487 on August 28, 2018 at an amount to not exceed \$675,000. Board approval of Agenda Item 1097 on August 1, 2023 revised the contract not to exceed amount to \$860,000 through March 9, 2024 due to higher than anticipated conversion of PlatePay customers to PIKEPASS customers. Board approval of Agenda Item 1163 on February 6, 2024 revised the contract not to exceed amount to \$1,115,000 through December 31, 2024 due to the continued higher than anticipated conversion. The proposed extension for 2025 will provide necessary time for a new vendor to onboard. It is anticipated that Oklahoman Direct will process approximately 490,000 transponders during the extended term end on December 31, 2025.

Submitted for consideration and approval of the Authority is a request to authorize the Director to negotiate and execute an amendment to the Agreement between the Oklahoma Turnpike Authority (OTA) and Service Oklahoma (SOK) that defines responsibilities under the Oklahoma Electronic Toll Collection Act. If this Amendment is adopted, OTA will reimburse SOK for certain costs and expenses necessary to implement an Electronic Vehicle Registration System authorized pursuant to the provisions of Senate Bill 2035 aka "The Mason Treat Act" which modified the procedures for vehicle registration and the issuance of temporary license plates. The implementation of these modified registration and plate issuance procedures will enable a more timely identification of a motor vehicle registered owner upon vehicle purchase or transfer, and help facilitate the OTA's collection of tolls. The OTA will reimburse SOK for the Public Awareness Program and actual implementation costs for an amount not to exceed \$750,000. The OTA will also reimburse SOK for costs associated with distribution of metal plates and temporary decals for an amount not to exceed \$500,000 on an annual basis.

RESOLUTION AUTHORIZING THE ISSUANCE OF OKLAHOMA TURNPIKE AUTHORITY OKLAHOMA TURNPIKE SYSTEM REVENUE BONDS CONSISTING OF SECOND SENIOR REVENUE BONDS, SERIES 2025A AND SERIES 2025B (OR AS FURTHER DESIGNATED BY YEAR AND SERIES), EACH IN ONE OR MORE SERIES OR SUBSERIES CONSTITUTING FIXED RATE BONDS, TO BE ISSUED AT ONE TIME OR FROM TIME TO TIME FOR THE PURPOSES OF FINANCING OR REFINANCING CAPITAL COSTS OF TURNPIKE PROJECTS AND IMPROVEMENTS TO THE OKLAHOMA TURNPIKE SYSTEM, REFUNDING OKLAHOMA TURNPIKE SYSTEM SECOND SENIOR REVENUE BONDS SERIES 2017A OF THE AUTHORITY, FUNDING CAPITALIZED INTEREST AND CERTAIN RESERVES WITH BOND PROCEEDS, AND PAYING COSTS OF ISSUANCE; APPROVING AND AUTHORIZING THE EXECUTION AND DELIVERY OF A TWENTY-FIRST SUPPLEMENTAL TRUST AGREEMENT PROVIDING FOR THE ISSUANCE OF SAID BONDS: AUTHORIZING A FORM OF BOND PURCHASE AGREEMENT AND A PRELIMINARY OFFICIAL STATEMENT AND APPROVING AND AUTHORIZING THE EXECUTION AND DELIVERY OF A FINAL OFFICIAL STATEMENT RELATING TO SAID BONDS; APPROVING THE AUTHORITY TO EXECUTE AND DELIVER A CONTINUING DISCLOSURE AGREEMENT, ESCROW DEPOSIT AGREEMENT, AND SUCH OTHER DOCUMENTS AND AGREEMENTS RELATING TO SAID BONDS AS MAY BE NECESSARY OR **REOUIRED; AUTHORIZING PROVISIONS FOR CREDIT ENHANCEMENT OF** SAID BONDS AS MAY BE BENEFICIAL; PROVIDING FOR THE NEGOTIATED SALE OF SAID BONDS; AND AUTHORIZING CERTAIN ACTIONS TO BE TAKEN TO EFFECTUATE THE ABOVE.

WHEREAS, the Oklahoma Turnpike Authority (the "Authority") has heretofore caused to be executed a Trust Agreement, dated as of February 1, 1989 (as amended and supplemented, the "Trust Agreement"), by and between the Authority and BOKF, NA (formerly known as Bank of Oklahoma, N.A.), of Oklahoma City, as successor Trustee (the "Trustee"), for the purpose of fixing and declaring the conditions upon which bonds are to be issued, authenticated, delivered, secured and accepted by all persons who shall from time to time be or become holders thereof, and in order to secure the payment of all the bonds at any time issued and outstanding thereunder, and the interest thereon, according to their tenor, purport and effect; and

WHEREAS, the Authority has, in accordance with resolutions adopted on December 22, 1988, February 16, 1989, September 20, 1991, October 18, 1991, May 15, 1992, June 10, 1992, August 21, 1992, September 21, 1992, April 16, 1998, April 18, 2002, June 26, 2006, April 18, 2007, October 29, 2009, August 18, 2011, October 28, 2014, March 31, 2016, September 27, 2016, September 26, 2017, August 28, 2018, June 23, 2020, and June 7, 2022 issued obligations (collectively, the "Outstanding Second Senior Revenue Bonds") under and pursuant to the Trust Agreement (as heretofore amended and supplemented, the "Trust Agreement" or "Agreement") for the purposes of (i) funding all or portion of the capital costs of certain Turnpike Projects and Improvements (as defined in the Trust Agreement) to the Oklahoma Turnpike System, (ii) refunding bonds previously issued by the Authority, (iii) funding reserves for and paying the costs of issuance of such obligations and (iv) paying capitalized interest; and

WHEREAS, all terms in this resolution, unless the context otherwise provides, shall have the meanings set forth in the Trust Agreement; and

WHEREAS, funds are now required to (i) finance or refinance all or a portion of the capital costs of certain Turnpike Projects and Improvements to the Oklahoma Turnpike System described below, including reimbursement of previously authorized capital expenditures, (ii) refund all or a portion of the Outstanding Oklahoma Turnpike System Second Senior Revenue Bonds Series 2017A, based on market conditions, (the "Refunded Bonds"), if determined to be in the interest of the Authority, (iii) fund capitalized interest and certain reserves, and (iv) pay the costs of issuance; and

WHEREAS, Section 209 of the Trust Agreement authorizes the issuance by the Authority of its second senior revenue bonds to provide funds, together with other available funds, for the purpose of completing payment of the cost of Turnpike Projects and Improvements to the Oklahoma Turnpike System and reserves therefore, paying any notes or other obligations issued by the Authority or repaying any advances from any source to provide temporary funds for the foregoing purposes, and paying the costs of issuance and related fees and expenses; and

WHEREAS, Section 210 of the Trust Agreement authorizes the issuance by the Authority of its refunding second senior revenue bonds to provide funds, together with other available funds, for the purpose of refunding all or a portion of outstanding second senior revenue bonds, and reserves therefore and paying the costs of issuance and related fees and expenses; and

WHEREAS, the Authority has determined and does hereby declare its intention to issue (a) second senior revenue bonds in one or more series or subseries (the "Series 2025A New Money Bonds") bearing a taxable or tax-exempt interest rate at negotiated sale to the Underwriters (as defined herein) for the purpose of (i) funding all or a portion of the capital costs of certain Turnpike Projects and Improvements to the Oklahoma Turnpike System, including reimbursement of previously authorized capital expenditures, namely for the projects defined in the Advancing and Connecting Communities and Economies Safely Statewide or "ACCESS Program" of the Authority (collectively, the "ACCESS Program Projects"), as the ACCESS Program and ACCESS Program Projects are described and defined on the Authority website accessoklahoma.com, (ii) funding capitalized interest and certain reserves, and (iii) paying the costs of issuance, and (b) second senior revenue bonds in one or more series or subseries (the "Series 2025B Refunding Bonds" and, together with the Series 2025A New Money Bonds, the "Series 2025 Bonds") bearing a taxable or tax-exempt interest rate at negotiated sale to the Underwriters (as defined herein) for the purpose of refunding the Refunded Bonds, if determined to be in the interest of the Authority, based on market conditions, (ii) funding certain reserves, and (iii) paying the costs of issuance, in each case in accordance with the terms and conditions of the Trust Agreement and one or more certificates of determination or further resolution of the Board (hereinafter described) whereby the Chairman of the Authority or, in his absence or incapacity, the Vice-Chairman of the Authority, or the Director of the Authority, will fix the aggregate principal amount of the Series 2025 Bonds and the sale date, issuance date, maturity dates, interest rates, discount, redemption provisions and for the application of the proceeds thereof; and

WHEREAS, the Authority has determined and does hereby declare its intention to authorize the execution and delivery of the Twenty-First Supplemental Trust Agreement or one or more additional supplemental trust agreements consistent with the terms of this resolution (such Twenty-First Supplemental Trust Agreement and additional supplemental trust agreements, if any, are referred to herein as the "Twenty-First Supplemental Trust Agreement") supplementing the Trust Agreement, as previously supplemented, which Twenty-First Supplemental Trust Agreement will set forth the details of the Series 2025 Bonds; and

WHEREAS, the Authority does hereby find and determine the issuance and sale of the Series 2025 Bonds for the purposes stated hereinabove to be in conformity with the purposes of the

Authority set forth in the Enabling Act (as defined in the Trust Agreement) and are in the public interest and otherwise beneficial to the State of Oklahoma (the "State"); and

WHEREAS, all necessary approvals by appropriate officers, authorities and agencies of the State have been or will be obtained; and

WHEREAS, on June 7, 2022, the Authority adopted a resolution (the "2022 Resolution") authorizing the issuance of up to \$1,000,000,000 of its second senior revenue bonds, among other purposes, funding all or a portion of the capital costs of certain Turnpike Projects and Improvements to the Oklahoma Turnpike System; and

WHEREAS, pursuant to such 2022 Resolution, the Authority has issued its Second Senior Revenue Bonds, Series 2023 (the "Series 2023 Bonds") in the principal amount of \$500,000,000, leaving remaining authority to issue up to \$500,000,000 of second senior revenue bonds pursuant to the 2022 Resolution which remaining authority the Authority desires to terminate; and

WHEREAS, the Authority shall seek advice and assistance from the Oklahoma Deputy Treasurer for Debt Management with respect to the issuance of the Series 2025 Bonds in accordance with the provisions of the Oklahoma Bond Oversight and Reform Act, Title 62, Oklahoma Statutes 2011, Sections 695.1 through 695.11, as amended;

NOW, THEREFORE, BE IT RESOLVED:

Section 1. The Authority hereby determines that it is in the best interest of the Authority and the State to issue, and accordingly hereby authorizes the issuance of, the Series 2025 Bonds. The Series 2025A New Money Bonds, to be issued as second senior revenue bonds, are authorized in an aggregate principal amount (exclusive of any original issue premium) sufficient for the purpose of (i) providing \$1,000,000,000 of funds to fund all or a portion of the capital costs of certain Turnpike Projects and Improvements to the Oklahoma Turnpike System, namely the ACCESS Program Projects, described and defined on the Authority website accessoklahoma.com, including reimbursement of previously authorized capital expenditures, (ii) funding capitalized interest and certain reserves (which reserves may met by a Reserve Policy, as defined herein), (iii) paying the costs of issuance, and (iv) accomplishing the other purposes established in this resolution. The Series 2025B Refunding Bonds, to be issued as second senior revenue bonds in a principal amount sufficient for such authorized purposes, are authorized for the purpose of (i) refunding the Refunded Bonds, if determined to be in the best interest of the Authority, based on market conditions, (ii) paying the costs of issuance, and (iii) accomplishing the other purposes established in this resolution. The Series 2025 Bonds may be issued in one or more series or subseries and in the amounts to be set forth in a supplemental trust agreement or one or more certificates of determination, subject to the conditions set forth below. The Series 2025 Bonds shall be sold and issued on such date or dates (including on a forward delivery basis with respect to the Series 2025B Refunding Bonds), shall be dated, designated and issued in such manner, shall mature on such date or dates, shall be subject to the right of prior redemption or tender, shall bear interest at such rate or rates, shall be issued in certificated or book entry eligible or book entry only form, and shall be payable on such dates as shall be specified in one or more certificates of determination and the Twenty-First Supplemental Trust Agreement. The Series 2025 Bonds shall be subject to redemption or tender at the option of the Authority, on such date or dates as the Authority shall determine.

The Series 2025 Bonds shall bear the manual or facsimile signatures of the Chairman of the Authority or, in his absence or incapacity, the Vice-Chairman of the Authority, or the Director of the Authority, and the Secretary and Treasurer or the Assistant Secretary and Treasurer of the Authority, and a facsimile of the official seal of the Authority shall be imprinted on the Series 2025 Bonds. The Series 2025 Bonds and the certificates of authentication by the Trustee to be endorsed thereon shall be substantially in the forms set forth in the Trust Agreement or the Twenty-First Supplemental Trust Agreement, as appropriate.

The Chairman of the Authority, or in his absence or incapacity, the Vice-Chairman of the Authority, or the Director of the Authority, is hereby authorized to negotiate and approve by one or more certificates of determination the forms of the financing documents requisite to or necessary for the issuance, sale and delivery of the Series 2025 Bonds (including on a forward delivery basis with respect to the Series 2025B Refunding Bonds) including but not limited to, preliminary and final official statements pertaining to said Series 2025 Bonds of the Authority; a bond purchase agreement to effectuate the negotiated sale of the Series 2025 Bonds to the Underwriters; a continuing disclosure agreement; an escrow deposit agreement; the Twenty-First Supplemental Trust Agreement pursuant to which the Series 2025 Bonds shall be issued; agreements with any bond insurers (the "Insurers") respecting insurance which may secure the Series 2025 Bonds or any part thereof, consistent with the provisions of the Trust Agreement; a surety, insurance policy, or other credit facility (the "Reserve Policy") for deposit into the reserve fund; and such other and further documents, instruments or certificates as shall be necessary to accomplish the issuance and delivery of the Series 2025 Bonds. The forms of such bond purchase agreement, preliminary official statement, continuing disclosure agreement, and Twenty-First Supplemental Trust Agreement shall be in forms consistent with this resolution and the forms of such documents delivered in connection with the issuance of the Series 2023 Bonds, including but not limited to any changes necessary to accommodate multiple series or subseries, changes to permit separate designations for different series or subseries, or designations to distinguish the Series 2025A New Money Bonds from the Series 2025B Refunding Bonds, and changes necessary to accomplish a forward delivery of all or a portion of the Series 2025B Refunding Bonds, with such changes consistent with this resolution as the Chairman or in his absence or incapacity, the Vice-Chairman, or the Director, may make, the execution of which shall be conclusive evidence of such changes.

All references to forms of the foregoing documents are deemed to refer to multiple forms, to the extent any Series 2025 Bonds have different dates of issuance.

Section 2. There is hereby delegated to the Chairman of the Authority or, in his absence or incapacity, the Vice-Chairman of the Authority, or the Director of the Authority, subject to the limitations contained herein and in the Trust Agreement, the power with respect to the Series 2025 Bonds to determine and carry out the following:

(a) The date or dates of issuance of the Series 2025 Bonds (including the issuance of all or a portion of the Series 2025B Refunding Bonds on a forward delivery basis), the bond designation (including designations other than "2025", "2025A" or "2025B"; separate designations for different series or subseries; or designations to distinguish the Series 2025A New Money Bonds from the Series 2025B Refunding Bonds), whether the Series 2025 Bonds shall be issued in one or more series or subseries, and the principal amount of Series 2025 Bonds to be issued, such principal amount not to exceed the principal amount permitted by Section 1 of this resolution in the case of the Series 2025A New Money Bonds;

(b) The interest rate or rates of the Series 2025 Bonds bearing a fixed rate of interest to maturity, the date from which interest on the Series 2025 Bonds shall accrue and the first interest payment date therefor; provided, however, that the true interest cost shall not exceed six per centum (6%) per annum;

(c) The amount of Refunded Bonds to be refunded and the maturities of such Refunded Bonds; provided, however, that any refunding of the Oklahoma Turnpike System Second Senior Revenue Bonds Series 2017A must result in an aggregate net present value savings of not less than three per centum (3.00%) of the aggregate refunded principal of such Refunded Bonds;

(d) The redemption date or dates, redemption price or redemption prices (including make-whole redemption), if any, subject to the terms of the Trust Agreement; provided, however, that the redemption premium payable upon such redemption shall not exceed two percent (2%) of the principal amount of such Series 2025 Bonds;

(e) The terms and conditions for the issuance of any of the Series 2025 Bonds, including with respect to the issuance of the Series 2025B Refunding Bonds on a forward delivery basis, and whether all or a portion of such bonds shall be issued bearing a tax-exempt or taxable rate of interest, and whether such bonds shall be issued in certificated or book-entry eligible or book-entry-only form;

(f) The principal amount of the Series 2025 Bonds to be issued for each of the purposes set forth in Section 1 of this resolution and whether such principal amount constitutes a separate series or subseries of Series 2025 Bonds, which principal amount (and the aggregate of all such subseries) in the case of Series 2025A New Money Bonds shall not exceed the principal amount permitted by Section 1 of this resolution;

(g) The maturity date or dates, interest payment dates and principal amount of each maturity of the Series 2025 Bonds; provided, however, that no Series 2025A New Money Bond shall mature later than the later of (a) 30 years from its date of original issue and (b) January 1, 2055 and no Series 2025B Refunding Bond shall mature later than January 1, 2047; the interest rate or rates of the Series 2025 Bonds or the manner of determining such interest rate or rates; provided further, however, that all of such Series 2025 Bonds shall be issued as Current Interest Bonds;

(h) The advisability, as compared to an unenhanced transaction, of obtaining one or more insurance policies issued by Insurers, to select a provider or providers thereof and to determine and accept the terms and provisions and price thereof, to determine such other matters related thereto as in the opinion of the officer executing the related certificate of determination shall be considered necessary or appropriate to effectuate such determinations by making any changes in or additions to this resolution or the Trust Agreement required by providers of such insurance policies, if any, or required by a rating agency in order to attain or maintain specific ratings on the Series 2025 Bonds, or payment of fees, premiums, expenses or any other amounts, notices, the provision of information, and such other matters of a technical, mechanical, procedural or descriptive nature necessary or appropriate to obtain or implement an insurance policy with respect to the Series 2025 Bonds, and to make any changes in connection therewith;

(i) Such changes in or from the form of this resolution or the Trust Agreement, not in conflict with the provisions hereof or of the Trust Agreement, as may be necessary or desirable in connection with obtaining a rating with respect to the Series 2025 Bonds, to re-designate the title of such bonds and to issue all or a portion thereof, together with any other series of second senior revenue bonds authorized by the Authority, or in order to cure any ambiguities, inconsistencies or other defects;

(j) The advisability of depositing one or more Reserve Policies into the reserve fund, to select a provider or providers thereof and to determine and accept the terms and provisions and price thereof, to determine such other matters related thereto as in the opinion of the officer executing the related certificate of determination shall be considered necessary or appropriate to effectuate such determinations

by making any changes in or additions to this resolution or the Trust Agreement required by providers of such Reserve Policies, if any, or required by a rating agency, or payment of fees, premiums, expenses or any other amounts, notices, the provision of information, and such other matters of a technical, mechanical, procedural or descriptive nature necessary or appropriate to obtain or implement a Reserve Policy, and to make any changes in connection therewith;

(k) Any other provision deemed advisable by the Chairman or, in his absence or incapacity, the Vice-Chairman of the Authority, or the Director of the Authority, not in conflict with the provisions hereof or of the Trust Agreement, including, without limitation, incorporating one or more policies of insurance by one or more Insurers or a Reserve Policy to the extent determined that such changes in connection with the Series 2025 Bonds would be in the best interest of the Authority.

The Chairman or, in his absence or incapacity, the Vice-Chairman of the Authority, or the Director of the Authority, shall execute one or more certificates evidencing determinations or other actions taken pursuant to the authority granted herein. Each such certificate shall constitute a certificate of determination and shall be conclusive evidence of the action or determination of such officer as to the matters stated therein. The provisions of each such certificate of determination as executed and delivered shall be deemed to be incorporated in this resolution as if set forth in this place.

Section 3. There is hereby delegated to the Chairman or Vice-Chairman of the Authority, or the Director of the Authority, subject to the limitations contained herein and in the Trust Agreement, the power with respect to the Series 2025 Bonds to select underwriters from the underwriting pool previously approved by the Authority and to award the sale to such underwriters for the Series 2025 Bonds (the "Underwriters") pursuant to the bond purchase agreement at a purchase price of not less than 97% nor greater than 140% of the par amount of such Series 2025 Bonds, exclusive of original issue discount, plus accrued interest thereon.

<u>Section 4</u>. The Authority hereby authorizes its Chairman, Vice-Chairman, or Director, to negotiate with Insurers for the provision of insurance policies for security purposes, of all or any portion of the Series 2025 Bonds approved hereby, and to negotiate with providers of Reserve Policies for deposit into reserve funds.

Section 5. BOKF, NA, is hereby acknowledged as the Trustee, Bond Registrar and Paying Agent for the Series 2025 Bonds.

Section 6. BOKF, NA, is hereby acknowledged as the Escrow Agent for the Refunded

Bonds.

Section 7. The Chairman or Vice-Chairman of the Authority, the Secretary and Treasurer or the Assistant Secretary and Treasurer, or the Director of the Authority are hereby authorized, directed and empowered to execute and deliver in the name and on behalf of the Authority the Series 2025 Bonds, Twenty-First Supplemental Trust Agreement, continuing disclosure agreement, escrow deposit agreement, bond purchase agreement, preliminary official statement and final official statement in the forms and containing such terms and provisions as shall be approved by the Chairman or, in his absence or incapacity, the Vice-Chairman of the Authority, or the Director, with such additions or modifications from the forms consistent with this resolution and the forms of such documents delivered in connection with the issuance of the Series 2023 Bonds including but not limited to any changes necessary to accommodate multiple series or subseries, changes to permit separate designations for different series or subseries, or designations to distinguish the Series 2025A New Money Bonds from the Series 2025B Refunding Bonds, as

shall be approved by such officers, the execution thereof by such officers being conclusive evidence of such approval, and to execute and deliver in the name and on behalf of the Authority all documents, closing papers, certificates and such other documents, closing papers, insurance commitments, certificates and such other documents as are necessary to accomplish the issuance and delivery of the Series 2025 Bonds, and the purposes established in this resolution.

Section 8. The signature of the officers of the Authority appearing on the Series 2025 Bonds, Twenty-First Supplemental Trust Agreement, continuing disclosure agreement, escrow deposit agreement, bond purchase agreement, final official statement, and other agreements, documents, closing papers and certificates executed and delivered pursuant to this resolution and the Trust Agreement shall be conclusive evidence of their approval thereof and their authority to execute and deliver such agreements and documents on behalf of the Authority.

Section 9. In conformity with and as provided in the Trust Agreement and the Twenty-First Supplemental Trust Agreement, it shall be the duty of the Trustee, simultaneously with the delivery of the Series 2025 Bonds herein authorized, to deposit in a special fund or funds created by the Trust Agreement, or apply in accordance with the provisions of the Trust Agreement, the proceeds of the Series 2025 Bonds issued pursuant to this resolution for the purpose of paying all or a portion of the capital costs of certain Turnpike Projects and Improvements, refunding the Refunded Bonds, and paying the costs of issuance of the Series 2025 Bonds, including, without limitation, premiums or costs of any bond insurance or Reserve Policy and directly funding any capitalized interest or necessary or required reserves or funds for such Series 2025 Bonds.

Section 10. The Series 2025 Bonds shall be executed in the manner set forth in the Trust Agreement and the Series 2025 Bonds shall be authenticated by the Bond Registrar and Trustee and shall be delivered to or for the account of the Underwriters upon receipt of the purchase price set forth in the bond purchase agreement accepted by the Authority as described above. The Bond Registrar is hereby authorized and directed to authenticate and the Trustee, upon such authentication, is hereby authorized and directed to deliver such Series 2025 Bonds as aforesaid upon satisfaction of all conditions precedent to such authentication and delivery contained in the Trust Agreement.

Section 11. The distribution of the preliminary official statement by the Authority in connection with the offering of the Series 2025 Bonds is hereby authorized. The Chairman or the Vice-Chairman or Director of the Authority as described above is hereby authorized and directed to execute and deliver the final official statement, including if applicable an updated official statement with respect to the Series 2025B Refunding Bonds sold on a forward delivery basis, to the Underwriters for their use in making a public offering of the Series 2025 Bonds upon the terms set forth in the preliminary official statement, with such changes, insertions and omissions as may be approved by the Chairman or Vice-Chairman or Director, and the execution by the Chairman or Vice-Chairman or Director of the final Official Statement for the Series 2025 Bonds, shall be conclusive evidence of any such approval.

Section 12. The Authority authorizes the selection of a financial printer, verification agent, escrow bidding agent, and other consultant resources in accordance with the applicable legal requirements of the Oklahoma Bond Oversight and Reform Act.

Section 13. The Board hereby approves the forms of the bond purchase agreement, preliminary official statement, continuing disclosure agreement, escrow deposit agreement, and Twenty-First Supplemental Trust Agreement, in forms consistent with this resolution and the forms of such documents delivered in connection with the issuance of the Series 2023 Bonds, and authorizes the Chairman, or in his absence or incapacity, Vice-Chairman, or Director to approve and execute such changes

thereto as may be deemed necessary or convenient to effectuate the purposes thereof, including but not limited to any changes necessary to accommodate issuance in multiple series or subseries, changes to permit separate designations for different series or subseries, or designations to distinguish the Series 2025A New Money Bonds from the Series 2025B Refunding Bonds, and changes necessary to accomplish a forward delivery of all or a portion of the Series 2025B Refunding Bonds.

Section 14. The members, officers, and employees of the Authority, and the officers and agents of the Trustee are hereby authorized and directed to perform all acts and things required of them by the provisions of the Series 2025 Bonds, the Trust Agreement, the Twenty-First Supplemental Trust Agreement, the continuing disclosure agreement, escrow deposit agreement, the bond purchase agreement, the final official statement, and documents related to any facility selected to provide credit enhancement for the Series 2025 Bonds, for the full, punctual and complete performance of all the terms, covenants, provisions and agreement of the Series 2025 Bonds, the Trust Agreement, the Twenty-First Supplemental Trust Agreement, the continuing disclosure agreement, the escrow deposit agreement, the bond purchase agreement, the series agreement, the final official statement, and any insurance commitments.

Section 15. The Board hereby authorizes and empowers the Chairman or Vice-Chairman of the Authority and the Secretary and Treasurer or any Assistant Secretary and Treasurer of the Authority and Director of the Authority to execute and deliver such further instruments, agreements and documents and to take such action as any of them deem necessary or desirable in order to carry out and perform the obligations of the Authority contained in the Trust Agreement, to effectuate the purposes thereof, and to consummate the transactions contemplated therein, subject to the limitations contained herein and in the Trust Agreement.

<u>Section 16</u>. Notwithstanding any provision of this resolution, the Board may, by resolution, make any determination delegated to the Chairman or Vice-Chairman of the Authority or Director of the Authority authorizing or pertaining to the issuance of the Series 2025 Bonds.

Section 17. The remaining, unused authority to issue Second Senior Bonds or other obligation pursuant to the 2022 Resolution is hereby terminated, and no further obligations may be issued pursuant to such 2022 Resolution; provided, however, that the authority relied upon for the issuance of the Series 2023 Bonds is not terminated.

WHEREAS, the monies for the improvement projects will be derived from the monies of the Authority available under the Trust Agreement, from the issuance of bonds and from other sources available to the Authority;

WHEREAS, the Authority desires to maximize its ability to reimburse itself for expenditures made for such turnpikes and turnpike improvement projects from the proceeds of one or more issues or series of Turnpike Revenue Bonds; and

WHEREAS, the Authority hereby amends and restates the 2022 Resolution in its entirety, as follows:

RESOLVED, that the Authority reasonably expects to reimburse the expenditures set forth in this Resolution with the proceeds of tax-exempt debt, in the form of Turnpike Revenue Bonds, expected to be issued by the Authority subsequent to the date hereof, and

RESOLVED, that this Resolution shall take effect immediately.

The projects currently contemplated by the Resolution of the Authority to which this Exhibit A is attached includes all or a portion of the following turnpikes and turnpike improvement projects, which constitute portions of the Advancing and Connecting Communities and Economies Safely Statewide or "ACCESS Program" of the Authority:

Turner Turnpike -- consists of widening the remaining ~60 mile segment of the four-lane Turner Turnpike between I-35 and Bristow to six lanes and adding lighting plus additional interchange access points.

Will Rogers Turnpike -- consists of widening the ~12 mile four-lane segment of the four-lane Will Rogers Turnpike between US-412 in Tulsa and Claremore to six lanes plus an interchange improvement at the SH-28 interchange.

Kilpatrick Turnpike -- consists of widening the remaining ~15 mile segment of the four-lane Kilpatrick Turnpike between I-40 to I-35 in Oklahoma City. Completing the existing interchange south of I-40 at SW 15th Street.

Gilcrease Expressway -- consists of ~5 miles of new roadway and bridge construction on a new alignment connecting the north terminus of the new Gilcrease Expressway West at Edison to the existing LL Tisdale Parkway in Tulsa.

South Extension Turnpike -- consists of ~19 miles of new roadway and bridge construction on a new alignment extending from the East-West Connector Turnpike to I-35 near Purcell.

East-West Connector Turnpike -- consists of ~28 miles of new roadway and bridge construction on a new portion of the OKC Outer Loop alignment from I-44 in the Tri-City area to I-40 at the Kickapoo Turnpike east of Oklahoma City.

Tri-City Connector Turnpike -- consists of ~8 miles of new roadway and bridge construction on a new portion of the OKC Outer Loop alignment extending the existing Kilpatrick Turnpike at SH-152 to I-44 in the Tri-City area.

System-Wide Access Improvements – consists of new construction and improvements of various interchanges and turnpikes across the system throughout the state. Improvements will be made to the HE Bailey, Creek, Indian Nation, Cimarron, Muskogee Turnpikes.

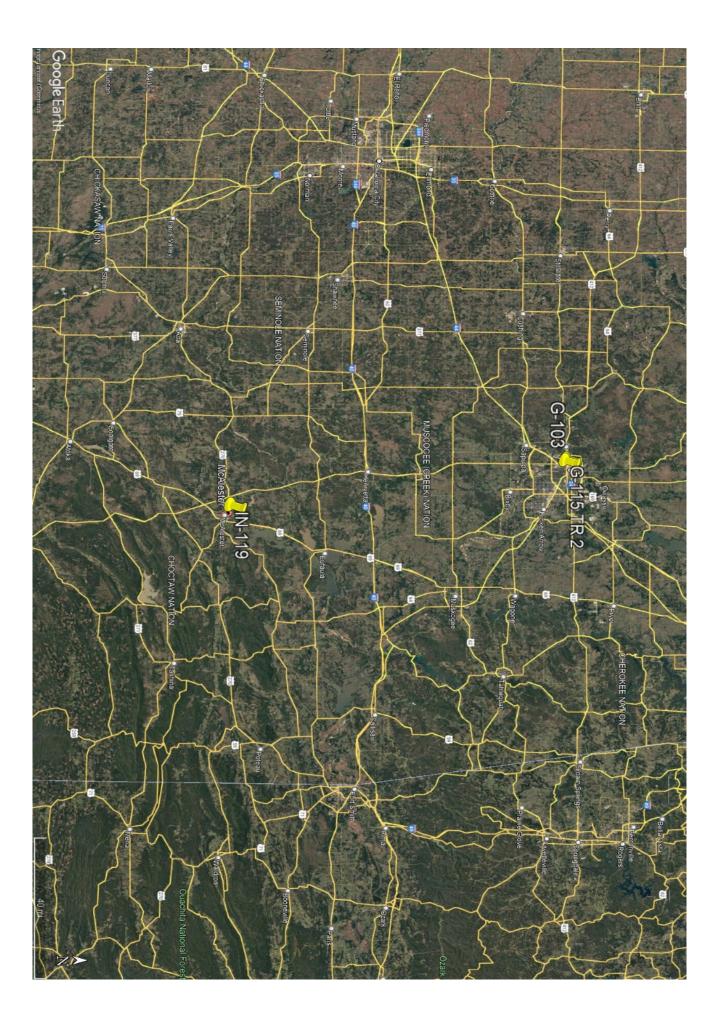

TURNPIKE REPORT

September 2024

For the month of September, troopers made 3,305 violator contacts, assisted 720 motorists, and investigated 215 motor vehicle collisions with two fatalities reported. Troopers worked 886 shifts and averaged 208 miles per shift for a total of 184,150 miles driven.

The Turnpike System reported two fatalities for the month of September.

Turner Turnpike – The driver was killed when the vehicle departed the road for an unknown reason and struck a bridge.

Creek Turnpike – The driver was killed after making an unsafe lane change and then being hit by another vehicle.

Drug Interdictions – Turner (5) Will Rogers (10)

Special Emphasis troopers worked 10 shifts on the Indian Nation, Cimarron, Turner, and H.E. Bailey Turnpikes and contacted 118 violators. These troopers issued 13 citations and 105 warnings for an average of 11.8 contacts per shift.

The aircraft enforcement flew a total of 0 hours.

During September troopers dedicated 139 hours to Toll Enforcement on the Turnpike System. During this time, they issued 80 citations and 355 warnings, confiscated 0 pike passes and issued 0 toll violation letters.

III. RECOGNITIONS AND OTHER AWARDS

Major Garrett Vowell recognized Trooper Seth Hudson as the OHP Trooper of the Month for October.

Currently in 2024, Trooper Hudson has seized \$263,00 in cash, 317 pounds of marijuana, 17.8 pounds of methamphetamine, ten pounds of mushrooms, and five pounds of cocaine. He also recovered 5,160 articles of stolen property, 51 bottles of promethazine, five firearms, and he made five DUI arrests. On September 19, 2024, in conjunction with Newton County SO in Missouri, he made a traffic stop on an assault and kidnapping suspect that had crossed into Oklahoma on the Will Rogers Turnpike. Trooper Hudson stopped the suspect near Afton and conducted a felony stop and safely placed the suspect into custody without incident. The passenger, a female, had been kidnapped and stabbed by the suspect. Trooper Hudson got her safely transported to the hospital. His continuous efforts are ensuring the turnpikes in Oklahoma are kept safe. He is a credit to OHP and the State of Oklahoma, with his dedicated service needs to be commended for his actions.

On behalf of the Board, Vice Chairman Berry thanked Trooper Hudson for his service and dedication to his work.

V. ITEMS OF BUSINESS

BUDGET ITEM(S)

ITEM 1223 Consider, take action and vote to accept the proposed Preliminary Annual Budget for the Oklahoma Turnpike Authority for the Calendar Year 2025 in the amount of \$156,267,926 for operations and maintenance of the turnpike system. Additionally, a \$165,495,322 Capital Budget for 2025 is incorporated. – Wendy Smith

Ms. Smith started by thanking Ms. Jonna Grant for her work on the 2025 Preliminary Annual Budget. Ms. Grant worked diligently with Division Directors to help prepare their budgets and ensured the divisions would obtain funds that would help provide OTA with high quality of services.

Ms. Smith presented the 2025 Budgeted Flow of funds which showed the expected annual flow of funds for 2025. This budget ensured that OTA would continue to operate the facilities, both safely and efficiently. This year's budget comes in at \$156.3 million, but that was only an increase of just under \$400,000 and results in a 0.26% increase over 2024's O&M budget. The significant categories include the following:

The Oklahoma Highway Patrol is set to graduate its newest cadets, and the Authority is excited to receive eight much needed troopers to its system. Additional troopers will provide patrolling and directing, movement of traffic, assisting citizens of the motoring public, along with cooperating with other law enforcement officers and public officials. This budget increase is just over \$835,000.

Regarding cashless tolling, as we eliminate those future cash expenditures and operating costs related to the more unsafe manual toll collection that we used to have, we are also increasing our O&M for those costs. Some of those increases include higher postage, a higher volume of license plate lookup, which is called manual image review, as well as bank service charges having increased as more and more customers are paying with credit cards. Concerning OTA's interoperability partners, we do have some fees that go up in conjunction with that, but we also have fees coming to us in miscellaneous income. With the streamlining of the Authority's tolling model, even with some of those increased expenses related to PlatePay, the authority saved approximately \$9.5 million as compared to 2024.

Ms. Smith continued stating, although inflation had improved over the last year, it cannot be fully eliminated. With continuing unprecedented low unemployment, attracting qualified applicants and retaining good employees is imperative for the Authority. To that end, the Authority did do a market adjustment to fill certain job classifications. The Authority also has seen increases in utilities and US Postal Service rates. Road maintenance costs continue to go up, including asphalt, concrete, drainage, and culvert costs, not to mention mowing and sweeping contracts that are competitively bid. This, plus the increased vehicle and equipment repairs that the Highway Patrol and the Maintenance Division budget have sustained due to supply chain disruption, all increase the O&M budget by about \$2.7 million.

To complete the explanation of increases to the O&M budget, due to the increase in the use of muchneeded software subscriptions to keep the Authority functioning efficiently, better technology for maintenance field workers, increased positions related to the ACCESS program and increased safety supplies, OTA has also seen an increase of another \$6.3 million. All of those increases and decreases come out to be about \$398,000 of an increase to the budget for 2025.

Ms. Dana Weber commented that OTA works from a zero-based budget every year, so that is what makes the budget presentation more impressive. She thanked Ms. Smith and Ms. Grant for their hard work.

Mr. Jordan Perdue began his presentation by pointing out the Gilcrease was a non-system project that did not benefit from the cross pledging of the Turnpike System. As part of this, the Gilcrease has separate budget procedures as negotiated with USDOT and the Build America Bureau. The system's general fund will cover the costs of the O&M for the Gilcrease. On a six month look back, the Gilcrease would reimburse the system on the actual expenses spent in this budget.

The Preliminary Budget is for \$1.3 million, which is an increase of \$168,000 from the 2024 budget. The vast majority is for an increase in toll collection costs because of the increase in transactions.

Item #1. Highway Patrol Report

Major Garrett Vowell presented the OHP report for the month of July. Turnpike Troopers made 2,946 violator contacts and assisted 691 motorists. There were 121 motor vehicle collisions investigated with two fatalities reported on the Will Rogers (1) and Kilpatrick Turnpikes (1). Thirteen drug interdictions were reported on the Will Rogers (5), Cimarron (1), and Turner Turnpikes (7). Major Vowell stated that the information for aircraft, motorcycle enforcement and toll enforcement were provided in the monthly report. Major Vowell noted he read the August report at the previous meeting.

Item #2. Consulting Engineer Report

Mr. Jimmy Sparks presented the Consulting Engineer Report. Concerning the Trust requirements, Mr. Sparks stated Olsson had submitted their 2024 inspection data for the final report to OTA staff. Within that is their recommendations for updates to the five-year capital projects that should be accelerated. Additionally, in September, Olsson engineers checked about 24 special overloads.

Mr. Sparks continued by giving a summary of comparisons over the past ten years of bridges and pavements. Since 2014, the NBI rating has increased from a 7.0 to a 7.2. The superstructure ratings have increased from a 7.5 to a 7.6, and the substructures have increased from a 7.0 to a 7.2. This is considered an average rating for the 350 OTA bridges. There was one bridge on the Indian Nation Turnpike at a deck rating 4, which placed the bridge in the structurally deficient category. This bridge is part of OTA project IN-MC-68 that began work in September 2024. Also, turnpike pavements, have seen an increase from the pavement condition index from an 84 to an 87. This puts the pavement in the industry-accepted "Good" category.

Mr. Sparks stated the "Good" category rating was due to the OTA's reinvestment back into the turnpike system. With the 2025 Preliminary Budget being approved, the reinvestment level will continue to allow the OTA's assets to perform at high levels. The 2025 through 2029 totals are over \$750 million, and over \$200 million for pavement rehab, \$50 million for dowel bar retrofit and diamond grinding, \$94 million for bridge rehabilitation, and \$71 million in shoulder and guardrail improvements.

Mr. Sparks concluded by saying for reserve maintenance, Olsson had done a comprehensive look at bridges and pavements and took a 15-year look at the number of projects. Looking at historical data and how many years between those ratings, it was calculated the reinvestment needs at \$35 million for 2025. That was due to the reinvestment back into the facilities and the capital plan.

Item #3. Trustee Report

Ms. Rachel Singleton stated as the Bond Trustee to the Authority, all monthly debt service transfers were made for the semi-annual payments due to the Bondholders, as required by the Trust Agreement. To the Trustee's knowledge, all other requirements set forth in the Trust Agreement had been satisfied.

Item #4. Operating Results and Financial Condition

Ms. Wendy Smith started out her report by expressing appreciation for the Board's consideration of the Preliminary Annual Budget for the System as well as the Preliminary Annual Budget for the Gilcrease Turnpike. As reported earlier, just as they do every year, each division manager takes a hard look their division's needs to ensure that the Authority budgets to provide services at the highest level. With these two approvals, the Authority continues to stay in compliance with its Trust Indenture.

Ms. Smith went on to state that the Gilcrease transactions continue to climb adding that he Gilcrease Turnpike has now been open long enough that its traffic volumes can be compared August to August year over year. The Gilcrease continues to be in that 5-year ramp up period that can take to level out. Daily transactions for the Gilcrease Turnpike have increased 41% compared to last August going from an average of 19,780 per day in August 2023 to 27,798 per day in August 2024. The Gilcrease is a commuter turnpike with weekday average daily traffic reaching just under 31,000 per day as compared to weekend average daily traffic reaching just over 20,600 per day.

Ms. Smith continued, stating that OTA continues to be in a strong financial position as can be seen from the Operations Report for August that was prepared by the Comptroller Division. In addition, today's Consulting Engineer's report regarding improvements in the OTA's major asset ratings are an important factor that are viewed positively by the Rating Agencies in its consideration of the Authority's AA- bond rating.

Ms. Smith added that year to date net toll revenues through August of 2024 for the Oklahoma Turnpike System continue to outpace year to date toll revenues thru August of 2023 by 7.9%. Collectively for the year, division managers held revenue fund operating expenses to 21.5% under the 2024 operating and maintenance budget. The OTA continues to steadily achieve and exceed its Trust-required senior and total debt service ratios.

Item #5. Director Report

Director Echelle began his report by thanking Ms. Wendy Smith and her team for the great job on the 2025 Preliminary Budget. He highlighted the tremendous service provided by the Oklahoma Highway Patrol and how he was proud the OTA was able to fund their cadet school. He also thanked Mr. Jordan Perdue for the great work done on the Gilcrease budget and how proud he was of that project.

Director Echelle went on to discuss the Right-of Way on-demand services contract modification that were presented earlier in the meeting. Currently the OTA is actively purchasing right-of-way associated with the ACCESS Program. The OTA has closed on 14 parcels so far through the program. Some are on the first segment of the East-West Connector, and some on the Turner Turnpike. As the OTA moves forward with plan completion, and after the 60% plans have been completed, that allows OTA to draw a right-of-way line. Then OTA is able to establish a legal description, do an appraisal and make an offer on some of the properties. This is an ongoing process, and there will be more updates in the coming months. He pointed the public to a phone number 1-844-56-ACCESS and website (info@accessoklahoma.com) so they could have their questions addressed.

Director Echelle continued his report by giving an update on cashless conversions. On August 28, 2024, the SH 9 ramps and Antlers and Eufaula Mainlines on the Indian Nation Turnpike were converted to cashless tolling. The final section of the Indian Nation is the McAlester Mainline, and it set to be converted in early November 2024. The final Turnpike, Will Rogers, is set to be converted in late November 2024. He expressed that with the turnpikes going to cashless tolling, there is a decrease in accidents.

Director Echelle concluded his report by reminding the public to wear their seatbelt. Also, if they experience an emergency, such as a flat tire, please get as far off the roadway as possible. Many fatalities are due to a patron stranded on the side of the road. In the event this happens, please get over as far as possible and call 911. Officers can assist you.

VIII. MOTION FOR ADJOURNMENT:

Vice-Chairman Berry called for adjournment to the next Regular Meeting of November 7, 2024. It was moved by Mr. Gene Love and seconded by Mr. Todd Cone that the meeting adjourn.

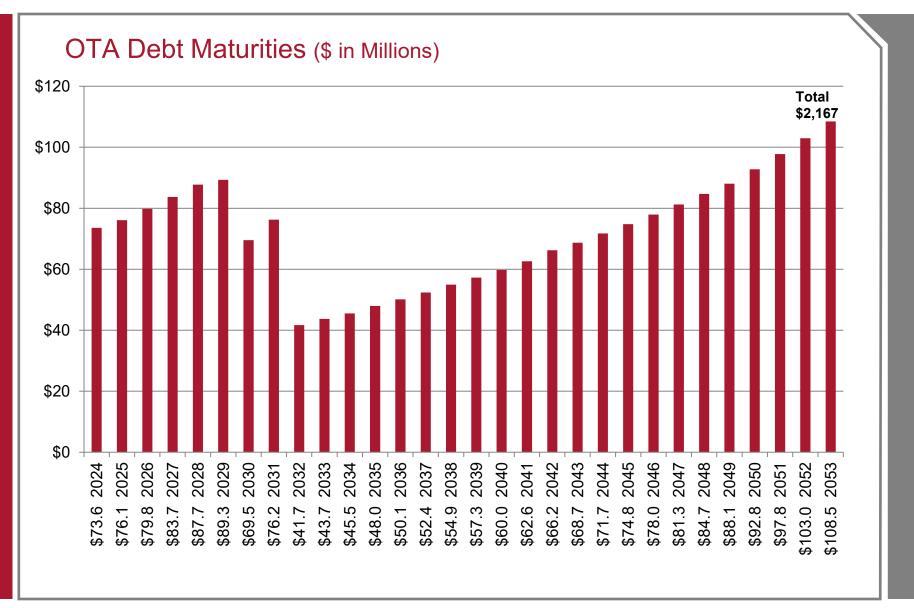

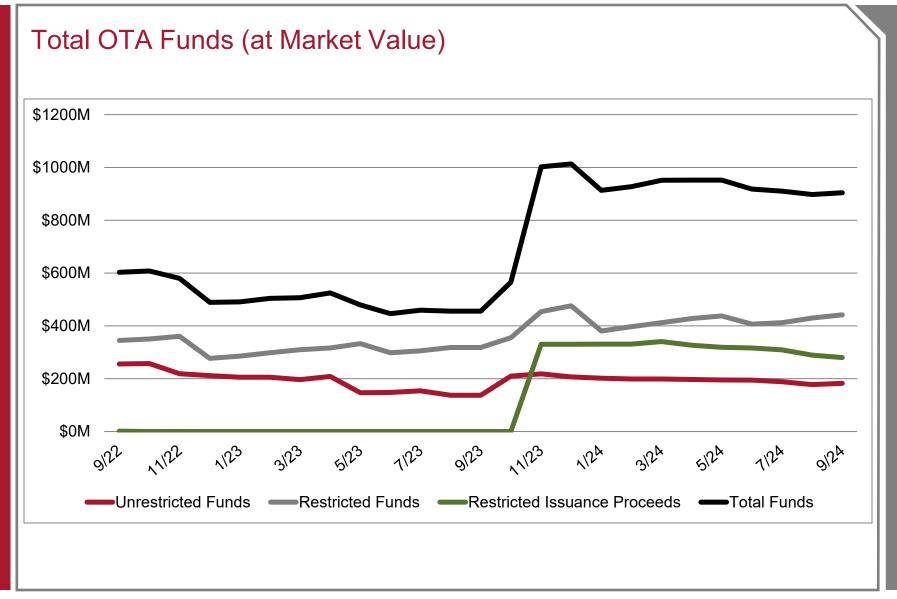

ACCESS Oklahoma Program

On February 22, 2022, Governor Kevin Stitt and Authority Executive Director/Oklahoma Secretary of Transportation Tim Gatz announced a new \$5 billion, 15-year turnpike improvement and expansion program known as "ACCESS Oklahoma: Advancing and Connecting Communities and Economies Safely Statewide" ("ACCESS Oklahoma"). The ACCESS Oklahoma program, to be undertaken in cooperation with ODOT, includes plans to make major investments in the turnpike system in the State to improve traffic safety, facilitate better movement of products and people, and provide new economic development opportunities in urban areas and rural Oklahoma.

ACCESS Oklahoma focuses on improving highway safety for motorists, increasing travel time reliability, easing congestion in metropolitan areas of the State, moving freight across the State and adding access to communities that previously were not connected to turnpikes. The new turnpike corridors in ACCESS Oklahoma will connect Oklahoma's existing highway system maintained by the State and provide reliever routes for Oklahoma's most congested highways, especially for commercial truck traffic.

Studies and preliminary design are underway for the projects currently expected to be included in the ACCESS Oklahoma program. These projects are expected to be financed from a portion of the proceeds of the Series 2023 Bonds and a number of additional issuances of Second Senior Bonds and potentially Junior Obligations over the next fifteen years.

Design, environmental, right-of way, and utility services are currently underway for several projects of the proposed projects. The ACCESS Oklahoma Program Manager is tracking these activities and coordinating with OTA and design consultants to develop project schedules.
